spots, there are a multitude of other cultural resources we have. Our aim is to show just how special Kissimmee can be."



Infected Blood Sucking the Confidence of Tampa Natives

State officials are becoming increasingly concerned about the tainted blood suffusing itself throughout Central Florida. The issue first revealed itself in the Kissimmee area, and was traced back to the OneBlood collection center. Whilst the blood was pulled from the Orlando area, these precautions were evidently insufficient to prevent the spread of that blood.

Four cases with flu-like symptoms identical to those found in Kissimmee were reported in the Tampa area. The tests that were run on the tainted blood in Kissimmee were unsuccessful in determining what, exactly, tainted the blood, but further tests are being conducted on this new batch of infected blood. Research has revealed that this tainted blood was collected by BayCare Laboratories. "The initial outbreak was concerning enough," said Dr. Alexa Roenthaw, the investigator from the Center for Disease Control said. "But the fact that the tainted blood has spread, particularly after OneBlood ceased its collection practices, is especially troubling. We will continue to investigate these anomalies, though this is looking more like some sort of terrorist attack more than an anomaly."

Medical experts and officials in Tampa are consulting with

those same personages in Kissimmee to protect both their patients and Hillsborough County. A similar shortage of blood is occurring in Hillsborough, which causes problems for hospitals and those needing surgery. "We're reaching out to the doctors, hospital administrators and county health officials for advice on this situation," said Dr. Lawrence Jannis, chief of surgery at Tampa General Hospital. "They've been through this before. Hopefully their insights can help prevent the difficulties they faced."

Alerts have gone out to all the adjoining counties, as well as to state officials, so they can be prepared in case their blood supplies become tainted. Efforts continue to identify the toxins infecting the blood. It is too early to determine if this is an epidemic, but fingers are crossed throughout the area.



Murder Victim Bodies Disappearing

While Orlando is experiencing a reduced murder rate, the police department is facing a puzzling quandary - disappearing murder victims.

The issue started several weeks ago, when a murder was reported on Orange Blossom Trail. The 911 call said that a young Hispanic male was involved in a fatal shooting, with a bullet wound to the head. This report was confirmed by officers on site. When detectives arrived at the morgue to discuss the autopsy, however, there was no body to be found. Additionally, the morgue had no indication that a body was delivered to their facility.

Other murder victims have faced similar circumstances,

with a total of 12 bodies positively identified as murder victims, yet no trace of the bodies could be found.



The coroner's reports indicate that the bodies were loaded onto the trucks but, somewhere between the crime scene and the morgue, the bodies have gone missing.

"This situation is exceedingly bothersome," said Police Chief Ed Warrens. "Our job is to ensure the public is safe and, barring that, to provide justice for the victims' family and friends. Of course, that becomes much more difficult when the murder victims go missing. A wealth of evidence - evidence which could lead to the killer or killers - is not available to our detectives, making their job much more difficult. The Orlando Police Department is looking at all solutions to the problem, including installing video cameras in our coroner's vehicles."

Copycat Killer on the Loose

A 30-year-old adjunct professor was found murdered near Buck Road in Orlando, but that's only the beginning of the story. Nelson, an adjunct professor of history, had wounds mirroring the injuries suffered by Mary Ann Nichols, the first victim of the notorious serial killer Jack the Ripper. Most notably, her throat was slit twice and her abdomen was mutilated. Police officials were reluctant to ascribe the murder as the work of a serial killer, as only one victim has been found, but they have not ruled out the possibility. "Obviously, the details of this murder harken back to Jack the Ripper," said Police Spokesperson Adda Rodriguez, "but we have no other details that indicate this is the work of a serial killer. We will continue our investigations, keeping in mind the horrific deeds committed by the Ripper, and keep our nose to the grindstone so that we can find the culprit."

Central Florida Fears Altrex Corp Buyout

The recent news of a possible Altrex Corp buyout has Orlando officials worried. The industry juggernaut Altrex Corporation has been a welcome addition to the city's financial landscape, as the corporation has injected a much-needed influx of jobs and money to the local economy.

Rumors have circulated, however, that Inner Ideas Incorporated, often referred to as Triple I or simply III, has made a move to acquire the biomedical and technology giant, a move that would catapult III into the upper echelons of corporate power. Parabolic Industries attempted to purchase Altrex as well but mysteriously withdrew their bid after negotiations stalled.

Of more immediate concern to local leaders, however, is what

this move would mean for Orlando and the rest of Central Florida. Altrex Corp has been a windfall for business interests in the area, providing economic stimulation in the form of jobs and money. The loss of such an economic powerhouse would have a domino effect on the area. Altrex Corp utilizes many local suppliers and distributors, and the loss of the parent company would mean possible dissolution for these smaller contractors.

Cheerleader Suicides Desolates Community

There is one puzzling detail about the deaths. The girls were found with their wrists slit, but there was very little blood found at the scene. While the girls were exsanguinated, this would indicate that the act was committed at a different location. It is difficult to imagine, however, how the girls moved themselves after making the incisions. Foul play was dismissed due to a lack of evidence. There were no defensive wounds on the girls and bloodwork indicated no drugs were in the girls' systems. The note did not indicate why the girls committed the act, just that they felt it had to be done.
